- 1) All dogs will be housed outside in a kennel with indoor dog shelter unless previous accommodations are made with Lake Pleasant Kennels ahead of time. (Weather permitting).
- 2) Payment is required in full at the time of pickup at the following rate. \$20 per day. An additional \$5 per day will apply if Lake Pleasant Kennels supplies the food.
- 3) All dogs must be current on all vaccinations and free of ticks and all other parasites.
- 4) Lake Pleasant Kennels uses Valley animal hospital for our veterinarian needs, if the owner requests the dog be brought to any other Veterinarian, mileage will be charged at the rate of 50 cents per mile. In the case of emergency Lake Pleasant Kennels will make all reasonable attempts to contact the owner. If we are unable to contact the owner, Lake Pleasant Kennels will seek Veterinarian care at LPK's discretion at the owner's expense. **In signing this agreement you are consenting to care for your dog at the facility of LPK's choosing.**
- 5) Lake Pleasant Kennels does not assume and shall not be held responsible for any liability with respects to the dog listed in the agreement, of any kind, or nature whatsoever, arising out of or from the boarding of this dog/s, or any damages which may accrue from any other cause whatsoever, including loss by fire, theft, runaway, injury to person, animal, or property, unavoidable causes, or death or injury to any other animal caused by the within named dog during the term of this contract.
- 6) Lake Pleasant Kennels does not assume and will not be held liable in the event of any damages or destruction to equipment, supplies or toys left with the dog listed in this agreement at the time of boarding.
- 7) This agreement will be good for a period of 1 year. Any changes to the answers or conditions listed above during the course of this agreement shall be brought to the attention of Lake Pleasant Kennels and may require that a new agreement be signed.
